1. Thank you for your interest in Rainy Day's baby-sitting services. The baby-sitting part of our services is a convenience to our customers. We do not recommend, we only refer our unlicensed sitters. We strongly recommend that the client, the baby-sitter, and the parents of the sitter meet in advance of service. The following is what you can expect:
2. Annual registration fee- \$39.95.
3. Fill out registration and agreement for service forms and submit, with registration payment, to Rainy Day prior to service.
4. Request for services in advance is recommended; however, we will do our best to provide you with the name of a potential baby-sitter that may be able to fill your needs that same day.
5. We contact the baby-sitter for you in advance to check their availability and continue to do so until we exhaust our list.
6. Person available will then contact you directly; or we will get an authorization from them for you to call them yourself.
7. Your needs can then be scheduled directly with them.
8. After the initial service, you may contact that individual without notifying or contacting Rainy Day. If they are not available, you may call us for a new referral at any time within the one year period for no additional charge.
9. Many of our sitters have participated in the Saint Alphonsus Baby-sitting course and may be CPR and first aid certified. All have experience baby-sitting children. If you need over night care, you may wish to use one of Rainy Day's professionally licensed staff. You may call anytime to inquire about those services.
